No. G.S.R. 10/Const./Art. 309/2011.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Women and Child Development Department (Group A) Service Rules, 1997, namely:—

1. These rules may be called the Haryana Women and Child Development Department (Group A) Service (Amendment) Rules, 2011.

2. In the Haryana Women and Child Development Department (Group A) Service Rules, 1997 (hereinafter called the said rules), in rule 5, for the words "thirty five", the word "forty" shall be substituted.

3. In the said rules, in Appendix B, under column 4, for the entry "Knowledge of Hindi upto Matric Standard" wherever occurring, the entry "Hindi/Sanskrit upto Matric Standard or Higher Education" shall be substituted.

4. In the said rules, for Appendices A, B, C and D, the following Appendices shall be substituted, namely:—
