No.848-SW(3)-2017 The use of Aadhaar as identifier for delivery of services/benefits/subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enable beneficiaries to get their entitlement directly to them in a convenient and hassle-free manner, Aadhaar obviates the need for producing multiple documents to prove one's identity. The provisions of the State Aadhaar Act and Regulations under the Act have come into effect from 23<sup>rd</sup> March 2017 in State of Haryana for the schemes funded out of Consolidate fund of State and notifications to this effect have been published in the Official Gazette.

The following services of Women and Child Development Department are an expenditure incurred from consolidated funds of State :

1. Integrated Child Development Services - Training programme
2. Maternity Benefit Programme
3. Protection & Empowerment of Women – Comprehensive scheme for combating trafficking of women and children – Ujjawla – Facilities to beneficiary.
4. Protection & Empowerment of Women – Comprehensive scheme for combating trafficking of women and children – Ujjawla – Salary.
5. Protection & Empowerment of Women – Support to Training-cum-Employment Programme.
6. Protection & Empowerment of Women – Swadhar Greh – facilities to beneficiaries
7. Protection & Empowerment of Women – Swadhar Greh – Salary to Staff
8. Protection & Empowerment of Women – National Mission for Empowerment of Women.
9. Rashtriya Mahila Kosh – Micro Loan to beneficiaries.
10. Integrated Child Protection Scheme – Salary of Staff
11. National Creche Scheme for children – Nutrition
12. National Creche Scheme for children – Honorarium to workers
13. Scheme for Adolescent Girls – Nutrition & Non-Nutrition
14. Integrated Child Development Services – Anganwadi Services –Supplementary Nutrition
15. Integrated Child Development Services – Honorarium to Anganwadi Workers and Anganwadi Helpers.

Accordingly, Women and Child Development Department in exercise of its powers under Section 3 of State Aadhaar Act, hereby notifies the following for all the above services:

- a. Individual desirous of availing above services/benefits/subsidies for above services are hereby required to furnish proof of possession of Aadhaar or undergo Aadhaar authentication.
- b. The downloaded Aadhaar (e-Aadhaar) is valid and secure electronic document which should be treated at par with printed Aadhaar letter.
